- \* Access to Justice computer, as well as, a computer station that is wheelchair/handicapped-accessible.
- \* Xbox 360 and Teen Computers in our Young Adult Room.
- \* We scan, fax, copy and print for a nominal fee.
- \* Children's Room equipped with touchscreen computers with interactive software.
- \* Monthly programming for adults and youths.

### **On-site Legal Resources:**

- \* Dedicated Computer for Access To Justice that is Tennessee Electronic Library accessible.
- \* Portable laptops with Skype.
- \* Print, copy, scan and fax.

- \* Over 50 legal reference guides, some with sample forms which may be reproduced.
- \* Additional 100 books & CD's on various legal topics available for loan.

- \* Newly-furnished meeting room, with reservations available for legal conferences.
- \* Staff with hands-on information for community services-food banks, shelters, etc.
